The following minimum prices for live chicken will be in effect from 8:01 p.m. January 28, 2012 until 8:00 p.m. March 24, 2012 (A-109).

1. The processor shall pay the producer an additional 3¢/kg. above the applicable category price for all loads when all of the following conditions are met:
 - a) The farmer makes more than 2 distinct shipments.
 - b) The extra shipments are a result of processor requests.
 - c) The shipments are all made from the same registered premises.
 - d) The shipments are all made from chicks placed on the same day.
 - e) The loads are less than 8,000 kgs. and are not made in conjunction with other loads to the same processor during the same shipment.
 - f) Where a farmer is contracted to more than one processor, the above conditions cannot be met as a result of combining shipments made to the two or more processors the farmer is contracted with.

2. For loads less than 8,000 kgs. not made in conjunction with other loads to the same processor during the same shipment, the following price schedule shall apply for the weight ranges indicated below, when shipped at the processors request:

Over 2.15 kgs. to 2.35 kgs.	\$1.587
Over 2.35 kgs. to 2.50 kgs.	\$1.597
Over 2.50 kgs. to 2.65 kgs.	\$1.607

NOTE: Starting in A-106, the live price will include a 'service charge' of \$0.001/kg. This service charge is CFO's temporary mechanism to collect the processor contribution to the cost of the Ontario Industry Strategic Plan 2013. Processors will collect the service charge with the producer licence fee(\$0.0140/kg) and the CFC levy (\$0.0044/kg) effective in A-106 for a total of \$0.0194/kg.
